Our international speakers:

David Elliot

David Elliot he has been a consultant for 30 years in the St. Andrew's Centre for Plastic Surgery in Essex, England, which currently treats over 4500 hand emergencies each year. Current interests are all hand trauma surgery, finger reconstructive techniques, flexor and extensor tendon surgery, Dupuytren's disease and the surgical treatment of peripheral nerve pain.

He also regularly operates in the Spanish health service.

He was an Open Scholar of Oxford University and won the BAPS Kay-Kilner prize, the BSSH Pulvertaft prize and the British Burns Association prize. He is the author of over 120 publications in the fields of plastic and hand surgery.

He is a past president of the British Association of Hand Therapists (1995-1998) and of BSSH (2005), and is a previous holder of a UK NHS Gold Merit award. He is a past editor of the Journal of Hand Surgery (European) and reviews regularly for the Indian Journal of Plastic Surgery.

He is a previous chairman of the Flexor Tendon Committee of the IFSSH and a previous examiner of the FESSH Diploma. He is an honorary member of the Association of Plastic Surgeons of India and of the Indian Society for Surgery of the Hand and has given the guest orations of both societies. He is an honorary member of the Swiss Hand Society and regularly teaches on hand surgical courses in Zurich.

He has been the invited Foundation Speaker twice of the Royal Australian College of Surgeons, the Kleinert-Kutz Professor in Louisville and a Visiting Hand Professor in South Africa. He has been a regular guest speaker throughout Europe, New Zealand and India.

His extracurricular activities include running a sheep and deer farm in the north of Scotland, several areas of historical research and playing the bagpipes.

Simon Kay

Professor Simon Kay is a Hand and Plastic Surgeon working in Leeds. His career has largely been devoted to microsurgical and micro neural management for children with birth differences or birth palsies. In the last ten years he has worked in collaboration with colleagues to develop the Hand Transplant service in Leeds. He is now able to reflect on 6 years of experience since the first UK hand transplant and is enthusiastic about the widening indications for this treatment as well as the insights into human behaviour it affords, but at the same time acknowledges the risks and costs associated with the transplants".
